Mr. Davis gave a description of what the applicant is requesting. The applicant proposes to demolish the existing single family dwelling and construct a two story building addition with an outside courtyard and playground.

Pastor Nelson has been with the church for the past 27 years and discussed the need for the expansion.

Mr. Phil Wells shared the exhibits and discussed the proposed changes to the site. The building height and elevations were then discussed. The first and second level floor plans were then shown and discussed followed by the lighting plan.

Mr. Mark DeBlasio spoke to the existing conditions of the property and then referred to exhibit A-7 to discuss the overall proposed conditions. The stormwater management meets the states requirements and there is no increase to the traffic expected. This proposal will allow traffic to move better for the "drop off" area. Mr. DeBlasio stated that he feels the lighting will be adequate for the site. The variances were then discussed and he feels there will be no negative impact.

The applicant has no issues with the letter from Mr. Polistina. The fencing around the basin was then discussed at length. Board member Purdy asked how deep the basin on 6<sup>th</sup> Avenue is.
